Dear Potential Winter Farmers' Market Vendor,

We would like to thank you for your interest in our Winter Farmers' Market in historic Port Washington, Wisconsin. We sincerely hope you are interested in joining us November 3, 2012 through May 25, 2013.

The Market will be held at First Congregational Church at 131 N. Webster St. (just west of the Niederkorn Library). While the weather permits we will occupy both the church's fellowship hall and the west side of Webster Street. Then with winter, we'll all retreat to the fellowship hall.

All vendor applications will be considered on a first come, first served basis. The Market gives priority to vendors who can provide locally grown produce and plants, hand-made prepared foods and hand-crafted products. While many applicants feel that they have the perfect fit for the market, it may not fit our focus. All applicants will be notified of acceptance / denial accordingly. Our goal here is to outline a general framework of what we see in our vision of what a farmers market should include.

**MARKET TIME AND SET UP:** Market vendors need to be in place no later than 8:45 AM each day of the specified Market morning. The Market will be open from 9:00 AM until 1:00 PM. For safety reasons no vendor will be allowed to leave prior to 1:00 PM. Except for emergency situations, any vendor who does vacate their space prior to the close of the Market will be in violation of the agreement.

**LICENSES & INSURANCE:** You are responsible for conforming to all applicable Federal, State and local laws that apply to your products. Individual product liability insurance and licenses are your responsibility.

**COSTS:** Your fees will be used to support the Market, as well as publicity. A 5-foot round table and an adequate number of chairs will be provided to each vendor.

- **Full Season Vendor** - \$130.00 for the 12-event season, per vendor space. As a seasonal vendor, we will provide you with the same space throughout the season.
- **Weekly Vendor** - \$15 per week
- **Cancellation / No Call ~ No Show Fee (under 24 hrs.)** - \$5.00

We plan to build on the success of our last two winter seasons; continuing to provide a community gathering place centered on local food and vendors. We look forward to your participation. The strength of any farmers' market depends on the presence of many vendors and a diversity of products. Signage, special displays and samples are highly encouraged. Be unique and treat every customer as a repeat customer.
